What we have achieved

- 2006** Influenced the Animal Welfare Act 2006 to give horses greater legal protection from suffering 
- 2010** Adoption of a Written Declaration supporting an end to the long-distance transport of horses across Europe for slaughter by the European Parliament 
- 2012** Reduction on the number of horses suffering long journeys across Europe for slaughter from 165,00 in 2001 to 54,000 
- 2013** Restriction in the privileges of the Tripartite Agreement to be applied only to 'high health' horses, such as FEI registered sports horses travelling to and from the continent 
- 2015** Introduction of the 2015 Control of Horses Act 
- 2015** Launched 'Practical Guidelines on Watering of Equine Animals Transported by Road' and 'Practical Guidelines to Assess Fitness for Transport of Equidae' 
- 2015** Produced 'Removing the Blinkers' – the first ever report on Europe's equine sector

Transport

An end to long-distance transportation of horses across Europe for slaughter

Tens of thousands of horses every year suffer as they are transported for thousands of miles across Europe for slaughter. We want this to be replaced with a carcase-only trade.



Responsible ownership

Responsible ownership of all horses

Horses across the EU remain vulnerable to neglect and ignorance of basic horse care. We want to reduce welfare problems through promoting responsible ownership, responsible breeding and responsible end-of-life decisions.



Equine ID

A robust equine identification system

The lack of a robust identification system leaves horses vulnerable to abandonment and mistreatment and would hamper the response to a disease outbreak. We want a strong system that links every horse to a responsible person.

What We Are Campaigning For



Disease

Protection from disease

Disease is a welfare issue. We work to reduce the threat of disease by chairing the UK's Equine Disease Coalition, lobbying for the UK's disease legislation to stay strong and funding research into disease. We also provide information for owners on how they can protect their horses.



Enforcement at ports

Checks on horses entering and leaving the UK

A lack of basic enforcement at our ports is leaving horses vulnerable to illegal trafficking by unscrupulous people. We want to see effective enforcement of the laws meant to protect the most vulnerable horses.



Welfare at slaughter

The highest possible welfare standards at slaughter

Humane slaughter is an important end-of-life route – but standards must be high. We want to see every horse treated with the respect it deserves from birth to death and the highest possible welfare standards whenever horses are slaughtered.
